Summary of Position: This position is responsible for designing, coding and modifying websites, from layout to function, and according our groups specifications. Strive to create visually appealing sites that feature user-friendly design, clear navigation, and accessibility by Rural Alaska (slower internet speeds). This is a temporary position and will finish on September 30th, 2020. It is possible that this position will continue after this date but is unknown at this time.

Primary Responsibilities, Duties, and Needs of the Position:

This position would be responsible for recommending alternative platforms for these sites that will be relatively easily updatable by managerial staff going forward. The menu structure will need to be changed for each site. Embedding a blog is needed in at least one of the sites, and video in one or more of the sites. The position will be responsible successfully implementing and managing substantial content changes and additions to these sites and changing the general layout of each site. Some of the sites will require basic data entry pages, allowing user friendly data input which populates a backend spreadsheet or database. Additionally, the position will update our social media platform presence.

Potentially addressing additional tech needs in our office, including maintaining laptops and computers, researching cloud platforms, setting up a group online calendar, and other general tech needs that come up.
